



SEDDON ON DEEDS, 2e

This book is the definitive Australian text on the law as it applies to the use of deeds by practitioners. It's about the technicalities of putting a deed together. Deeds are used by practitioners for a variety of purposes and it's easy to get the mechanics wrong. The COVID pandemic has stimulated changes to the law to enable electronic deeds. However, this has occurred in substantial and satisfactory legislation only under the Corporations Act and in Queensland. New South Wales and Victoria have enabled electronic deeds but otherwise have not adjusted the applicable law.


WORK HEALTH AND SAFETY REGULATION IN AUSTRALIA




LEARNING TO LITIGATE: A Guide for Young Lawyers






COMMONWEALTH CRIMINAL LAW, 3e




SOCIAL SECURITY AND FAMILY ASSISTANCE LAW, 4e




DYNAMIC AND PRINCIPLED: The Influence of Sir Anthony Mason

The winner of the <u>Holt Prize 2021</u> is an important work on how the law compensates Indigenous Australians for the loss or impairment of native title rights. Although statutory entitlements to compensation have been available in the *Native Title Act 1993* (Cth) since its commencement, it was not until 2016 that the first judicial determination of compensation was made. A key theme throughout the book is a recognition of a tension between the desirability of applying existing legal principles and doctrines, while also recognising the uniqueness of native title.



Q and A: Nick Seddon

The contract law author speaks about deeds and what it means to write an Australian law text

When you published your book *Seddon on Deeds* in 2015 it was the first Australian book on the subject. What inspired you to write a local text?

Lawyers were using an English text of 1928. It was time for a comprehensive Australian text on the technicalities of deeds. This led me on a surprisingly interesting journey, including the occasional visit to the dusty old *English Reports* looking exactly the same online as in the law library.

The law of deeds is based on ancient law, yet contemporary lawyers must use deeds all the time. What's a common trap for unsuspecting lawyers?

Trying to understand the legislation, particularly at state level. It is terrible. You never quite know whether the formalities required will be applied strictly or with some flexibility. There are many traps. Probably the most common mistake is attesting. A person with no knowledge or interest in a transaction is grabbed to witness a signature. Getting that wrong can nullify the deed.

The wording used in deeds has changed over time from solemn and formal to more casual and modern. What's a word you'd be happy never to see in a deed again?

Witnesseth.

Your new edition of *Seddon on Deeds* is coming out with us later in the year. What's one change you'll address in the new edition?

Just one? Well, the most important change is to the *Corporations Act* enabling companies to use electronic deeds. It took a few goes, but they got it right in the end.

What did you find out about deeds that surprised even you while writing this book?

I found out that lawyers use deeds, which are hazardous, when a contract will do the job. The most common example of this mystery is the use of a deed for a settlement.

Why should people buy the book?

This is not for people. No-one other than a lawyer would have the slightest interest. So lawyers should get it and make sure that, if they think a deed is necessary, it is properly assembled and executed and does not fall foul of a pernickety judge who also needs a copy.

Nick's new edition of *Seddon on Deeds* is due out this September. The first edition has been cited by Supreme Courts, District and County Courts throughout the country (no fewer than 38 times, by our count). **Pre-order your copy here.**
