




THE NEGOTIATION OF KEY MERGER & ACQUISITION CLAUSES: Getting the Deal Done

It addresses the negotiation of key clauses in M&A transactions from start to completion; detailing the typical underlying commercial considerations and critical issues behind the identified clauses. It then sets out standard or appropriate approaches to such clauses. The book serves two purposes: a conceptual purpose, to show how a complex legal transaction can be traced to underlying commercial considerations; and a pedagogic purpose, to highlight the underlying structure of an important transactional instrument: the M&A contract. This will be an important resource for company directors, lawyers, bankers, and students.


THE APPELLATE JURISDICTION OF THE COURTS IN AUSTRALIA, 2e

In addition, it deals with the jurisdiction and powers of appellate courts, and what alternative remedies are available if there is no right of appeal. Appellate courts also have original jurisdiction, and this is likewise considered. Civil appeals and criminal appeals are dealt with separately because, although there are commonalities between them, criminal appeals in particular give rise to different considerations. Other chapters cover appeals from military tribunals, the new Federal Circuit and Family Court of Australia and the Federal Court.








WORK HEALTH AND SAFETY REGULATION IN AUSTRALIA


ZINES AND STELLIOS'S THE HIGH COURT AND THE CONSTITUTION, 7e
