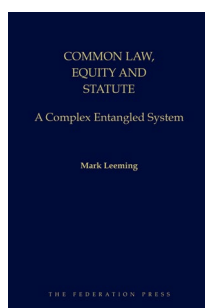

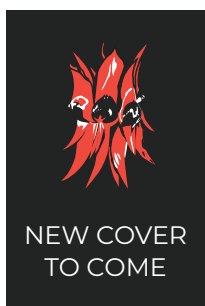


COMMON LAW, EQUITY AND STATUTE: A Complex Entangled System

Mark Leeming

This strikingly original book analyses what is meant by the 'common law of Australia', what is the relationship between judge-made law and statutes, and how courts resolve novel questions of law. It explains why some questions are best regarded as aspects of the common law, why others are best regarded as questions of statutory construction, why some are difficult to characterise, and why this matters. It also explains why equity continues to be a distinct component of judge-made law, with a different relationship with statute. And it gives a nuanced account of precedent and the role of authority from different jurisdictions. The book will be an invaluable resource for judges, for those arguing points of law before them, and for all those who seek a sophisticated understanding of how the law is applied and developed by our courts.

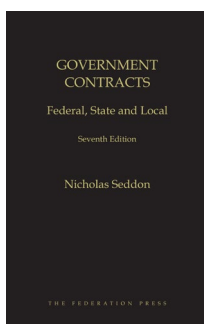


THE CONSTRUCTION AND PERFORMANCE OF COMMERCIAL CONTRACTS, 3 ed

The third edition of this work analyses a number of commonly found boilerplate clauses in commercial contracts and illustrates, through case law, how they have been judicially interpreted. Each chapter concludes with recommendations as to the issues that should be considered when drafting such clauses. The emphasis of the book is upon the application of the principles of contract directly to the construction of contracts and is not merely a recitation of those principles. Several recent appellate court decisions (including those of the HCA, NSWCA and VCA) have been added to this edition to illustrate points of construction.

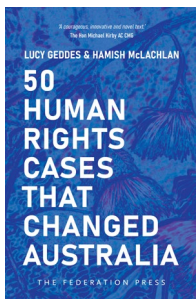


THE APPELLATE JURISDICTION OF THE COURTS IN AUSTRALIA, 2 ed **Dean Mildren**

The second edition of this well-received work describes and discusses the principles of law and practice which guide Australian appellate courts at all levels. In addition, it deals with the jurisdiction and powers of appellate courts, and what alternative remedies are available if there is no right of appeal. Appellate courts also have original jurisdiction, and this is likewise considered. Civil appeals and criminal appeals are dealt with separately because, although there are commonalities between them, criminal appeals in particular give rise to different considerations. Other chapters cover appeals from military tribunals, the new Federal Circuit and Family Court of Australia, and the Federal Court.

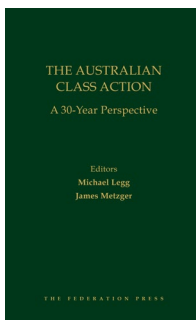


50 HUMAN RIGHTS CASES THAT CHANGED AUSTRALIA

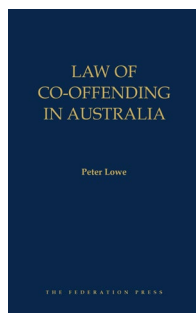


THE AUSTRALIAN CLASS ACTION: A 30-Year Perspective

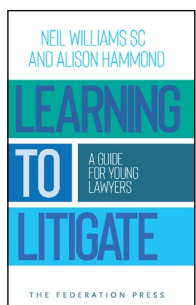


LAW OF CO-OFFENDING IN AUSTRALIA: Principles Applicable to Co-accused Trials

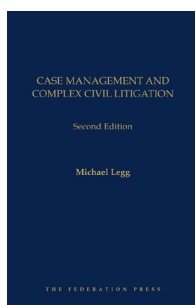


LEARNING TO LITIGATE: A Guide for Young Lawyers
